REMOTE LEARNING COVID-19 GUIDELINES



CPAA understands the serious impact Coronavirus (COVID-19) is having on our community. We will continue to monitor the news regarding the virus and follow all CDC and NCDHHS guidelines. We also understand the importance of maintaining as much normalcy as possible for our kids. CPAA will offer an environment similar to what our kids are used to in an in-person classroom setting. CPAA's remote learning space can accommodate 45 kids but will only accept 35 to allow more than the 6 feet social distancing recommendation. Spots will be filled on a first-come, first-served basis.

There are several holidays during the Fall semester. If you are traveling during any of these holidays, please monitor your child's risk of exposure and consider selfquarantining for 14 days before returning to our space.

ARRIVAL & PICK-UP

Before You Leave your home

Parents will be required to self-screen their child at home, prior to coming to the studio each day. Self-screening shall include checking temperature, and checking for symptoms including cough, shortness of breath, gastrointestinal symptoms, abdominal pain, unexplained rash, new loss of taste/smell, muscle aches, or any other symptoms that feel like a cold. Any child with a fever of 99.4°F or above or any other signs of illness should stay home.

Curbside Drop-off

Children will be dropped off at curbside and greeted by a CPAA staff member. Parents, caregivers, siblings and or guests arriving/dropping off students will remain in their vehicles.

All outerwear (jackets, hats, pull-over hoodies) must immediately be placed in a designated area in the studio. These items will not be allowed in the learning space.

Children will not be allowed into the building carrying a backpack. All school supplies must be placed in a personal/mini plastic crate (Dimensions: 9 x 7.88 x 6.13) which will be carried into the learning space, used to hold student's belongings during class, and carried home when the student leaves for the day (**Please label your child's crate with their first and last name and sanitize their crate at home daily. Crates can be purchased at Amazon, Target, and Walmart**).

Children must remove their street shoes and place them on the shoe rack at the entrance of the studio.

Children will enter the building and leave the building wearing a mask. Student will not be required to wear a mask when they're at their desk, but all movement in the learning space and outside throughout the day will require a mask, i.e. going to the bathroom, visiting with the teacher, outside time, etc.

As recommended by CDC and NCDHHS, your child should eat breakfast at home and pack his/her lunch and two snacks. Lunch and snacks will be eaten at their desks. After lunch and both snacks, the rooms will be cleaned and sanitized. Water bottles may be brought to class if they have a cover and are labeled with the child's first and last name.

All personal items including crates, masks, shoes, and water bottles must be labeled with child's first and last name. (Please sanitize all items at home daily.)

Children will maintain proper social distance as they enter the studio.

They will be greeted by their teacher/facilitator upon entering the learning space.

Pick-Up from Class

Students will be escorted outside for curbside pick-up. It is imperative that each student is picked up on time to limit contact with dance students and for our staff to properly clean and sanitize the studio. If a student's ride is going to be late, the office must be notified as soon as possible. There will be a \$5/minute charge for late pick up. The student will remain in a designated indoor area (breakroom) away from groups while awaiting pickup. Frequent tardy pick-ups will result in dismissal from the program

IN-CLASS PROTOCOL

Hand sanitizer stations are on the walls outside of each learning space. Children will be required/instructed to use hand sanitizer before entering their space.

Once in the space, children will be instructed to place their crate in a designated area inside the classroom

All personal items will be kept inside the crate during class when not in use

Children will refrain from any physical contact and maintain six feet social distance during class and outside play

Floors will be marked with signage to indicate proper social distance

Children will be permitted to remove masks while at their desk

All staff will wear a mask while moving around the learning space and during individual instruction.

Children will be allowed to go to the bathroom one at a time. CPAA staff will be available to assist when needed. Please encourage your child to wash their hands after each bathroom use. Hand Sanitizer must be used prior to reentering the dance space.

If a Student Becomes Sick

If a student begins exhibiting symptoms after they arrive to class, they will be removed from the classroom and will wait in a designated area (breakroom) away from other kids. Our office staff will contact parents to pick up their child immediately. Our office staff will notify classmates' parents by email of possible exposure, and any confirmed case of COVID-19. Parents must always keep their contact information up to date in our system.

Symptomatic children and staff will be required to take a 14-day leave of absence, and a doctor's note will be required upon returning to the learning space. CPAA will notify all studio families and local health officials about large increases in child and staff absences or substantial increases in respiratory illnesses (like the common cold or the "flu," which have symptoms similar to symptoms of COVID-19).

CLEANING PROTOCOL

All learning spaces will be cleaned and sanitized throughout the day.

Bathrooms and the lobby will be cleaned and sanitized several times throughout the day.

All areas of the studio will be thoroughly cleaned every night after closing.

UV Lights have been used for years to disinfect and kill viruses. They are used in hospitals, wastewater treatment plants and food preparation facilities. UV lamps will be used nightly to disinfect all areas of the studio. These lights will be scheduled for automatic disinfecting after hours when everyone is out of the building.

The studio will be disinfected on Saturday night every 14 days using a Disinfectant Fogger.

The studio will be cleaned professionally 2-3 times a week.

OUR PLAN

Our plan is to operate under these guidelines for a long as needed. Please note, all guidelines will be amended as needed.
